

COMPETITION "LABEL OF QUINTA DA RAZA PET-NAT 2019 - AUTHOR SPECIAL EDITION"

GOALS OF THE COMPETITION AND APPLICATION

1. Presentation of an original label for the bottle presented in the post published on the Facebook page of Quinta da Raza.
2. The label is intended for an **author special edition**, to be used in a new project by Quinta da Raza Lda, RAZA PET-NAT. The wine will be a "Petillant Naturel", a natural sparkling wine produced by a method dating from the 16th century. Tradition, irreverence, but also the natural aspect of the label will be valued.

PARTICIPATION

1. Participation in the Competition is open to anyone with an interest in Design, Communication, Marketing, Fine Arts, Architecture or other similar areas.

RECEIVING THE WORKS

1. Entries may be sent to the email geral@quintadaraza.pt, until 11:59pm of April 30, 2020.
2. All entries are subject to approval by Quinta da Raza after verification. An email will be sent to all participants to confirm receipt of the work.

EVALUATION AND SELECTION

1. The works will be handled to a jury to select a winner.
2. The jury's decision is final and not subject to complaint.

JURY

1. The jury of the Competition is composed by the Quinta da Raza team, who will evaluate the entries in terms of creativity, originality and suitability for the type of wine and its characteristics.

PRESENTATION OF RESULTS

1. The Jury will award 1 winner who, after the deliberations, will be announced on Quinta da Raza's digital communication media (website, Facebook, LinkedIn and Instagram) on May 7, 2020.
2. The prize "**LABEL QUINTA DA RAZA PET-NAT 2019 - AUTHOR SPECIAL EDITION**" delivery will take place at the beginning of May 2020.

AWARD

The winner will receive a monetary prize (personal and non-transferable) in the amount of €150, as well as a wine box with 1 bottle of each of the references in the Dom Diogo and Quinta da Raza brands' portfolio.

The winning entry will also see its name published in the author special edition, as well as its disclosure in all communication media of Quinta da Raza, Lda.

RIGHTS

2. Quinta da Raza Lda reserves the right to modify or suspend the competition, at any time, in case of a computer anomaly or in the event of verification of actions that may indicate the practice of criminal offenses.
3. Quinta da Raza Lda reserves the right to disqualify participants who deliberately try to brake, at some point, the rules and spirit of the Competition.
